IMPORTANT INFORMATION TO ALL EQUESTRIAN PARTICIPANTS

Freds Pass Rural Show has successfully implemented a system where Entry Passes to the show must be pre-purchased. This alleviates the bottleneck of traffic leading into the Reserve.

Passes can ONLY be obtained from the Show Office prior to the Show by COB Friday 6 May 2011. Fees can be paid directly into Show bank account. Contact Show Office on (08) 8983 1626. All Equestrian participants are required to pre-purchase passes, including participants for the Friday events.

**** WITHOUT A SHOW PASS – NO ENTRY TO SHOWGROUNDS ****

Without a Show Membership Competitors will be unable to enter side gate to the equestrian area for parking (float or truck) and will be required to park (float or truck) in general parking area.

REFUNDS: Refunds are subject to the production of a Vet or Doctor Certificate stating that the horse/rider was suffering a condition that would prevent them from competing.

SPECIAL NOTE: Any events not supported this year may be eliminated from the program in future years. Classes may be split if sufficient entries. Class may be cancelled at the FPRS Committee discretion.

SHOW MEMBERSHIP PRICES

Adult Weekend Pass \$35 (Includes Equestrian/Vehicle Pass)

Junior Weekend Pass \$10 (5years and under as of 01/05/2011 - FREE)

Family Weekend Pass \$66 (Includes Equestrian/Vehicle Pass)

Day Passes/Entry can be purchased at the Show entry points; day entry competitors will be required to park (Float or Truck) in general parking area.

Horses returning interstate or below the tick line require an inspection, supervised treatment and permit from Stock Inspector.

All Equestrian competitors will require an Equestrian pass to enable them to park in the Equestrian car park. Without an Equestrian Pass you will have to park in the general parking area. Passes can be obtained from the Show Office.
